### ESSENTIAL DUTIES AND RESPONSIBILITIES

#### 1. <u>Production/Rehearsal/Performances:</u>

- a. Responsible for reading script and making rough sketches for review by the Director and production team.
- b. Consult with Director and Choreographer regarding designs and potential problems.
- c. Determine which costume items can be provided by the cast and arrange with the cast to provide these.
- d. To the maximum extent possible, arrange to borrow costumes.
- e. When purchases are necessary, consult with the Technical Director and remain within budget limitations.
- f. Construct costumes according to designs indicated.
- g. Provide ample notification and clarification to cast of items they must supply.
- h. Arrange for costume assistants as needed and review their progress.
- i. Schedule costume parade with the Director.
- j. Keep tabs on all costumes.
- k. Make a scene by scene costume chart for each cast member.
- I. Repair costumes as needed.

#### 2. Post Production:

- a. Coordinate strike of costumes and arrange their return to the proper source (arrange for cleaning if needed).
- b. Responsible for cleaning costumes after the production ends.

### QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Must be available in early December for auditions.
- Must be available January through early March for rehearsals which will be scheduled a minimum of two
  nights per week from approximately 7:00 pm 10:00 pm. Time commitment may increase and include
  weekends two weeks prior to opening night.
- Must have experience in costume design.
- Must be able to organize people, time, and equipment in the most efficient way for the task at hand.
- Must be available to discuss problems as they arise with the various technical section heads and work out solutions with the directorial staff in a timely manner.
- Must be a strong team player.

### **EDUCATION and/or EXPERIENCE**

• Minimum of 3 years relevant costume experience in the field of theatre.
